


D1 Black Top List

E1 M8 x 16mm Screws



Measure and mount the metal wall mount bar (A1)





If a second bar is needed, repeat the same procedure with B1. The part A1 and B1 is easy to connect to each other to build a long video row.



Installation procedure is the same for both landscape and portrait. Put the screen in portrait or landscape mode. Add VESA connector to the backside with M8 screws.


VESA connectors should be connected to the upper VESA holes






The screen can now be attached to the wall mount bar (A1)

Detailed warranty terms

- Transport damage should be reported to us within four working days
- Send the signed shipping document to support@hi-nd.se to receive a RMA number. We require photos of the damaged product, packaging and label.
- Send the product back to HI-ND on a pallet in the original package. The purchaser pays the freight cost.
- We will send a credit if the product is found faulty after our quality controls.

Warranty does not apply under the following conditions:

If scratches on protection glass or metal are not visible from 100 cm distance

If scratches are less then 10 mm in length

If the product has been repaired or modified by other companies than HI-ND

If the product has not been installed in accordance with the installation manual

If the product has been mounted with incorrect mounting fittings to wall, floor or ceiling
